

Course design: introduction to the collection

Overview

One of the points made by Elaine Showalter in her book *Teaching Literature* (Blackwell, 2003) is that 'it is not always easy to find out what our colleagues are doing behind those closed classroom doors' (p.9). As she observes, this is what tends to separate teaching from other public professions such as law or medicine; many teachers rarely discuss what they do in the classroom with colleagues teaching similar material. Recently, however, this sense of teaching as a 'privatized' profession has, as Showalter notes, been broken up, thanks in part to the increasing willingness on the part of teachers – or at least their institutions – to post programme and module resources up on the Internet. In this unit, we approach the process of module design in part by talking to colleagues about how they have successfully designed whole programmes and individual modules. By sharing their practice with us and therefore with you, the processes involved in module design are made a little more transparent. This collection provides a space for you to experiment and think creatively about ways to enhance the modules you currently teach or ones you might teach in the future. It is rare to have the opportunity to design a whole programme from scratch but nearly all of us will be involved in programme revalidations and in that context we think it is also beneficial to think about programme design too.
